# I. Approval of the Minutes of January 2024

A motion to approve the December minutes was made by Mayor Heye-Townsell, seconded by Mayor Farmer, and passed by the Board.

# II. Financial Statement for January 2024

A motion to approve the financial statement was made by Mayor Heye-Townsell, seconded by Mayor Gastineau, and passed by the Board.

# III. Metroplan Report

Mr. Covington stated that since the last meeting, staff has focused on planning projects tracking and reimbursements. Projects that are still open on the books are being worked on by staff to get them closed out for 2023. Staff continues to work on the EEI grant. Staff is also working on the Safe Streets for All grant as well as working on office organization.

Mr. Covington also stated that recertification will be coming up in early summer. This will include a couple of activities that will involve participation by Board members.

Mr. Covington noted that over the last couple of weeks staff attended groundbreaking ceremonies for the Old River Bridge in Saline County, a key piece of the Southwest Trail. Metroplan also attended the groundbreaking for the Southeast Trail, which will go from the Clinton Library to the Airport.

Mr. Covington also noted that Ms. Dozier is working on the creation of a Heels & Wheels Podcast on transportation. An introductory podcast has been filmed and the next episode will feature the Regional Greenways.

Ms. Dozier stated that the podcast will examine transportation topics in Central Arkansas. In the podcast there will be discussions about different types of partnerships, projects and things that are going on that are crucial to the region.

Ms. Dozier noted that staff would be reaching out to our members to participate and talk about the region. The podcast will be available on all listening media including Spotify. Any comments or questions will be open for submission.

The first episode is scheduled to be aired on the first Friday in April.

Mr. Covington added that there are several key dates for grants that were noted during the meeting. Key dates for SS4A are March 15<sup>th</sup> and August 28<sup>th</sup>. Submission for bridges is on September 8<sup>th</sup>, Low Emission Vehicles comes in April, as well as several other grants that were mentioned in the meeting.

Mr. Covington noted that he recently attended a meeting with various MPOs on the Federal Reauthorization Process. A couple of things that were of priority for reauthorization were the increase in planning funds, modifications to discretionary funding programs, and match required. Mr. Covington added that a major priority is keeping advance appropriations which would be critical to the receipt of funding on a yearly basis.

Mr. Covington also noted that the Downtown Partnership will be having the Annual meeting on March 28<sup>th</sup>. Metroplan will have a table of eight available for anyone wanting to attend on a first-come-first-served basis. If anyone is interested, they should contact Metroplan to reserve a spot.

# **IV.** Agency Reports

# A. Arkansas Department of Transportation

Mr. Farmahan gave a report on the following projects as awarded:

Contracts awarded at the February 28, 2024, bid letting in the CARTS area.

• Highway 381 in Lonoke County, from Hwy. 70 to Hwy. 232(S) (Job A60037)

Mill and Overlay approximately **12.2 miles \$3.7M**, CK Asphalt, LLC.

• Highway 89 in Lonoke and Pulaski County, from Cabot to Hwy 107(S) (Job A60038)

Mill and Overlay approximately **6.1 miles \$2.0M**, CK Asphalt, LLC.

• Highways 60, 64 & 65B in Faulkner County, selected sections in Conway (Job A80028)

Mill and Overlay approximately **5.9 miles \$6.3M**, Rogers Group, Inc.

• Various City Streets in Pulaski County, in Jacksonville (Job C60014)

Overlay and surfacing approx. 1.8 miles through the State Aid Street Program

• Trammel Rd. in Pulaski County, in Sherwood (Job C60013)

# **B. Rock Region METRO**

Ms. Becca Green gave the report for Rock Region METRO.

Ms. Green stated to the Board that Rock Region METRO continues to work on their super shelters. Work has begun on the first of three that will be installed in areas that have the highest ridership. The first will be at Willow St. and Pershing Blvd. in North Little Rock that serves the routes for Levy/Amboy and McCain routes and the Levy/Amboy – McCain micro-transit routes. The new shelters will be bigger and include charging stations along with digital real-route information.

Ms. Green further noted that at the end of the month Rock Region will begin its Intelligent Transportation Systems (ITS) process. This will be the second system that

the company has ever had. The process will take about 12 -18 months to implement but will be very beneficial to freeing up time.

Ms. Green added that Rock Region just recently filed for a RAISE grant for transit redevelopment for the River Cities Travel Center. This is something that the Rock Region METRO has been working toward for a few years and the feasibility portion has been completed.

Lastly, Ms. Green indicated that Monday would be National Transit Employee Appreciation Day. This is the first time that it is being noted on a national basis.

# C. Little Rock Port Authority

Ms. Guffey gave a report for the Little Rock Port Authority.

Ms. Guffey stated to the Board that Mr. Day was in Washington advocating for the region.

Ms. Guffey announced to the Board that the Port had received a Congressional grant for a transit facility at the port. This will be used for road improvements. Rail traffic continues to expand because of all the new locations along the port. It is expected that there will be some press about the new groundbreaking in the upcoming week.

# **D. Bill & Hillary Clinton National Airport**

There was no one in attendance from the National Airport.

# E. Federal Highway Administration

Ms. Amy Heflin stated to the Board that the Active Transportation Infrastructure Investment Program, which is geared toward bicycle and pedestrian grants, will come later in March. Also, there is a pilot program that will be focused on transit-oriented development plans coming in April. She encouraged the Board to look into it.

Ms. Heflin added that the discretionary grants provide an opportunity for a de-briefing service of any applications submitted, whether the project is an issue, or the application is an issue. This will also offer ways to make the project more competitive.

Ms. Heflin also indicated that there is a tool on the DOT website that can allow you to briefly describe your project. This tool will figure out what funding opportunities might be available to fit the project. Ms. Heflin stated that she would send a link to the tool to Mr. Covington for distribution.

Lastly, Ms. Heflin introduced a new planner on staff at FHWA, Mr. Truett Smith.

# F. Federal Congressional Offices

A brief report was provided by representatives from congressional offices.

# G. Central Arkansas Planning and Development District

Ms. Spencer stated to the Board that in developing a grant, staff from the Central Arkansas Planning and Development District would be visiting with the jurisdictions in the region to become more knowledgeable about the area and better able to help them in finding appropriate grant opportunities.

Ms. Spencer added that there will be a subcommittee meeting held on March 28<sup>th</sup> with UALR to review the survey results for the SEDs plan. During the meeting they will develop goals and objectives that will later be presented to the full committee. The committee will develop a SEDS document for submission to CAPDD and then to EPA.

Ms. Spencer noted that a Regional Stakeholders Committee has been established that consists of the economic environment and development persons in the area. The committee meets every second Tuesday of the month in various locations. Ms. Spencer indicated that the Board is welcome to provide anyone from their jurisdiction in this arena to participate in the committee. Submissions should be sent to Ms. Spencer at conya.spencer@capdd.org.

# V. Energy and Environment Innovation Plan

Ms. Rhodes stated to the Board that Metroplan was taking on a lead role for the submittal of an application to EPA for the carbon reduction grant. Metroplan is also partnering with other regions in the state to develop regional plans to submit a joint coalition implementation application. Metroplan is working with the Northwest Arkansas Region and the City of Fort Smith to develop the plan. The purpose of the plan is to develop ways to reduce greenhouse gas emissions.

The allocation process was included in the Board packet for review.

Ms. Rhodes gave the Board a brief overview of the process.

A motion to adopt Resolution 24-01 was made by Mayor Farmer, seconded by Mayor Chamberlain, and approved by the Board.

# VI. Safe Streets and Roads for All

Mr. Roberts gave a briefing on deadline dates to apply for grants funding under the Safe Streets and Roads for All grant.

Mr. Roberts stated to the Board that adoption of the regional plan by the Board is expected on April 24<sup>th</sup>, with the construction grant due May 15<sup>th</sup> and the planning grant in August.

Mr. Vinson added that one of the requirements for the grant is for the Metroplan Board to approve an aggressive reduction in fatalities and serious injuries. As a result of the previous workshop, there was a schedule created with several options that are part of the plan; a 10% reduction by 2030, a 25% reduction by 2035, 40% reduction by 2040, 60% reduction by 2045, and an 80% reduction by 2050.

Mr. Vinson noted that the Board had chosen to go with the 40% reduction amount as shown in the resolution.

A motion to adopt Resolution 24-02 was made by Mayor Farmer, seconded by Mayor Gastineau, and approved by the Board.

Mr. Covington stated that he would like to have the Board meet again in a couple of weeks with those especially interested in applying for the grants available to help them determine which grants are applicable for their area.

Mr. Covington anticipated this meeting within the first week of April.

# VII. Long-Range Metropolitan Transportation Plan

Mr. Holland gave the Board a brief overview of the Long-Range Metropolitan Transportation Plan.

Mr. Holland stated to the Board that the public comment period ended in February. There were minimal comments with some minor edits to the plan with no substantial modifications.

In December the goals and policies were discussed, in January the financials, and in this meeting the graphics of Chapter 2 were discussed.

Mr. Holland stated that Chapter 2 examines population characteristics and overall land use.

A motion to adopt Resolution 24-03 was made by Mayor Gastineau, seconded by Mayor Riley, and approved by the Board.

# VIII. 2024 TAP and CIE Projects

Mr. Covington stated to the Board that a total of ten applications were received for TAP and CIE projects for the 2024 funding cycle. The applications were reviewed and scored by a six-person scoring committee. A recommendation was made to fund five applications for TAP funding - \$320,000 each. Four additional CIE awards were recommended for \$120,000 each. The list of the projects that were selected was included in the Board packet.

Mr. Covington stated to the Board that the remaining CIE would be include in the next round of TAP Call for Projects.

A motion to adopt Resolution 24-04 was made by Mayor Farmer, seconded by Mayor Hartwick, and approved by the Board.

A motion to adopt Resolution 24-05 was made by Mayor Chamberlain, seconded by Mayor Hartwick, and approved by the Board.

# IX. 2024 Project Obligations

Mr. Covington stated that ARDOT expressed to Central and Northwest Arkansas that all funds must be obligated this year. Therefore, it is critical that all projects on the list must be obligated. It is the intent of staff to reach out to the city engineers to review each project to ensure that the projects will be ready to obligate by September. At that time the list will be submitted to ARDOT.

Mr. Covington encouraged the Board to reach out to staff for help with moving the projects forward.

With no further business the meeting was adjourned.



# SUMMARY

Metroplan submitted the grant proposal *Energy and Environment Innovation for the Natural State* to the EPA on March 29<sup>th</sup>. # ITEM 6. SAFE STREETS AND ROADS FOR ALL GRANT UPDATE

# SUMMARY

The draft of the Regional Safety Action Plan was provided to the Metroplan Board and members of the Safety Action Plan Advisory Committee on March 29<sup>th</sup>. A revised version of the document reflecting edits from committee members and Metroplan staff is attached to the Board notification. Adoption of the plan will facilitate jurisdictions applying for implementation funding in the FY 2024 cycle (May 16 deadline). Kimley Horn is formatting the plan for publication.

Representatives of the consulting team and Metroplan will schedule a meeting with Board Members to review high injury network corridors within their jurisdictions. This information and input from

board members will be used to inform county plans that will accompany the regional plan, scheduled for completion this summer. Additionally, Metroplan staff is reviewing a supplemental planning/demonstration grant application for August that would facilitate projects to evaluate concepts included in the plan. Staff will be engaging with members on the application.

### **RESOLUTION 24-06**

# A RESOLUTION APPROVING THE REGIONAL COMPREHENSIVE SAFETY ACTION PLAN SAFE STREETS AND ROADS FOR ALL

**WHEREAS**, Metroplan is the officially designated Metropolitan Planning Organization (MPO) for the Little Rock-North Little Rock-Conway metropolitan area; and

**WHEREAS**, the MPO is charged with the responsibility of providing for the continuing, cooperative and comprehensive transportation planning process for the Central Arkansas Regional Transportation Study;

**WHEREAS**, Metroplan received a Safe Streets and Roads for All planning grant to develop a regional Safety Action Plan (Resolution 22-15);

**WHEREAS**, the Metroplan Board of Directors, Policy Board of the MPO, recognizes that fatalities and serious injuries are not inevitable and chooses to aspire to Vision Zero to eliminate all fatal and serious injuries and sets a goal of reducing fatal and serious injury crashes by 40% by 2040 (Resolution 24-02);

**WHEREAS**, Metroplan has completed the consultant-led Regional Safey Action Plan, which was developed through consultation with expert stakeholders, Board members, the Safety Action Plan Advisory Committee, and public outreach across Central Arkansas;

WHEREAS, the Regional Safey Action Plan meets the requirements of the Safe Streets and Roads for All;

**WHEREAS**, county-specific plans are being developed and will be incorporated into the regional plan as completed;

**NOW, THEREFORE, BE IT RESOLVED**, that the Metroplan Board of Directors, the Policy Committee of the MPO:

Section 1: That the Central Arkansas Regional Comprehensive Safety Action Plan is hereby approved and identifies a wide variety of strategies, goals, and potential projects.

Section 2: Will develop yearly progress reports through staff identifying changes in the number of fatal and serious Injuries and high injury locations.

# ITEM 7. SMART Streets Plan (Partnership with ARDOT)

# SUMMARY

Consistent with the direction of the Board (June 2023), Metroplan staff engaged ARDOT staff in a scope for Central Arkansas SMART Streets Plan. The recently adopted Metropolitan Transportation Plan, *Central Arkansas Transforming Mobility*, and ARDOT's Strategic Plan, *Full Steam Ahead*, both acknowledge the growing role of technology in the transportation network and need for its integration into projects. Metroplan and ARDOT staff are proposing an initial phase that will:

### **Define a Central Arkansas Smart Street**

- Researching Smart Technologies and Federal Initiatives to identify potential Smart Street strategies and project types for Central Arkansas
  - V2I & V2X initiatives (vehicle to infrastructure and vehicle to everything)
  - o ITS America
  - US DOT SMART Street Grant Program
  - Federal Highway Complete Streets
  - Managed Lane Applications
  - Infrastructure Accommodations (striping and lighting)
- Engagement of Transportation Professionals for defining a Central Arkansas Smart Street
  - State DOT and Local Agency Staff
  - Professional Organizations (WTS, APA, ITS)
  - Industry Personnel and Business (Transit Agencies, Arkansas Trucking, Delivery & Logistics Services, Chambers of Commerce)
  - Education (Universities and STEAM programs)
  - Transportation Advocates and General Public
- Development of Central Arkansas Smart Streets Examples
- Reviewing and Updating CARTS ITS Architecture minor update

Metroplan is proposing funding for this initial phase would come from a combination of Carryover Planning Funds from Metroplan and match from ARDOT.

A goal of the project is to apply in 2025 for the SMART Grant Program though the US Department of Transportation for phase II of the study focusing on implementation and demonstration projects.

Dear Director Tudor

On behalf of the Metroplan Board of Directors, I am requesting a partnership with the Arkansas Department of Transportation (ARDOT) for the Development of a Central Arkansas SMART Streets Plan and CARTS ITS Architecture update.

As technology is transforming transportation modes, it is imperative that cities, counties and ARDOT work cooperatively to ensure that transportation decisions today facilitate opportunities for the future. ARDOT's participation in this study is representative of the relationship between ARDOT and local public agencies for managing traffic operations on state highways while leveraging its existing staff expertise. A critical piece of this forthcoming technology is connected vehicles and vehicle-to-infrastructure technology defined in the National ITS Architecture.

It is apparent that ARDOT recognizes technologies' increasing role in Transportation, as demonstrated in ARDOT's Strategic Plan, *Full STEAM Ahead*, and its core value of Modern – Innovation for the Future. Recent implementation of technology and innovation include ARDOT's Traffic Management Center and Managed Lanes on the I-430 Arkansas River Bridge.

The Metroplan Board of Directors also recognizes this importance, with its new Metropolitan Transportation Plan, *Central Arkansas Transforming Mobility*, including a core policy to embrace new technologies and best practices to optimize mobility and protect the environment. As the primary operator of traffic signals, Metroplan jurisdictions are actively pursuing the latest technology for coordinated signal systems.

Following input from ARDOT Staff, the initial phase of the project would focus on defining a Central Arkansas Smart Street and inform transportation officials and the public of forthcoming opportunities. It should be forward looking, ensure consistent technology across the region (and hopefully state), and focus on applications relevant to Arkansas.

Partnering with Metroplan on this study is a proactive opportunity to look beyond today and define the future of streets and highways in Arkansas Metropolitan areas. It will also position ARDOT and Metroplan to successfully compete in the new discretionary Grant Program from the Infrastructure Investment and Jobs Act, *Strengthening Mobility and Revolutionizing Transportation (SMART)*.

The Metroplan Board and Staff are committed to:

- Providing up to \$300,000 in carryover Federal-aid Planning Funds for Phase I of the study, to be matched by ARDOT.
- Coordinating with ARDOT to develop a project scope for an on-call planning consultant.
- Assisting with oversight of the consultant.
- Coordinating with city and county staff overseeing operations on streets and state highways.
- Assisting with public outreach and education.

This proposed partnering arrangement would only be for Phase 1 of the study. If the results from Phase 1 prove mutually beneficial, then arrangements could be pursued for additional phases. I look forward to hearing from you regarding this important opportunity.

# SUMMARY

The Unified Planning Work Program (UPWP) includes all transportation planning activities conducted within the Metroplan study area. In May 2023, Metroplan adopted a two-year UPWP covering the period from July 1, 2023, to June 30, 2025.

For a two-year UPWP, the second year is reviewed and may be revised for tasks or budget. Metroplan staff expects to complete all tasks/deliverables within the two-year period. No adjustment to work tasks are proposed. Budget adjustments are proposed for the following.

- 1. Funding Sources and Amounts for SMART Streets Plan
- 2. Updated Funding for Safe Street and Roads for All
