Population: 3460 (2020 Census)


Location: Lonoke County, Central Arkansas

## History

• The City was established in 1872 when the St. Louis, Iron Mountain and Southern Railroad built the railroad approximately one mile southeast of Old Austin. Many residents of Old Austin moved near the railroad tracks, in some cases uprooting and transporting entire buildings. The new city forming near the tracks was originally known as "Austin Station" to distinguish it from the original Austin but eventually became known as Austin while the old community became known as "Old Austin".

# **Location & Information**


- The City of Austin is in northern Lonoke County sharing borders with the City of Cabot and Ward.
- Austin is split along Interstate 57(Highway 67/167) consisting of 3 square miles of land.
- Median Household Income: \$93,315

• The City of Austin had a tremendous growth change from 2010 to 2018 with numerous housing developments completed during that time. Austin had encountered slow growth from 2019-2023. In 2024, neighborhood developments have increased, and land has become available to developers.

## **Public Works Department**



- Public Works Department consists of 7 full time employees. 3 Office/Administration Personnel and 4 Field Personnel.
- Water, Sewer, and Street departments fall under Public Works.

## **Public Works Department - Water**

- Quality water sourced from Greers Ferry Lake
- Ownership partners in Lonoke
   White Public Water Authority and is
   a long-term water source for Austin
   residents.
- Public Works handles all maintenance, repairs, and operation of the Austin Water Distribution System



## **Public Works Department - Wastewater**

- All wastewater is treated at the Austin Wastewater Treatment Plant Facility.
- 3-million-dollar treatment plant upgrade completed in 2024 with capacity for future growth.
- System consists of 10 collection pump stations, 20 collection pumps, 1 wastewater treatment plant



## **Public Works Department - Streets**

- Austin Public Works is responsible for 21 miles of streets within the City.
- Public Works has adopted a street conditions map with project planning for the next several years.



## **Parks & Recreation**

- City of Austin currently has one city park, The Howard and Edith Martin Memorial park located on South First Street.
- A master park plan was completed in 2023 to provide for future planning of the property. The master plan includes 3 pickleball courts, soccer field, walking track, community garden, permanent restrooms, new playground, parking, and more.



#### Call to Order

Mayor Gastineau called the meeting to order at 9:00 a.m. He welcomed participants and asked participants to introduce themselves.

#### 2. Introductions & Announcements

Participants introduced themselves. Ms. Brittany Nichols was introduced as the new Sustainable Transportation and Energy Ambassador of Metroplan. Mayor Chamberlain told the council that the City of Austin was the city in Spotlight for the meeting. Ms. Bernadette Rhodes was promoted to the position of the Deputy Director for Metroplan, and it was also discussed that she will still be involved with her current role of Senior Regional Planner for Partnerships & Grants.

#### 3. Summary of Previous Meeting

Mayor Gatineau made a motion to approve the summary of the November 22, 2024, meeting. Mayor. Chamberlain seconded the motion. The motion passed unanimously.

#### 4. Community Spotlight: City of Austin:

Mayor Chamberlain led this section by introducing the history of the City of Austin with the council. She mentioned how the city got its name due to the residents moving from Old Austin to near the railway tracks and forming a new city originally called "Austin Station". The city has a median household income of \$93,315 and a median age of 30. It shares its borders with Ward and Cabbot. Discussing the recent burst of growth form 2010 to 2018, Mayor Chamberlain discussed how new housing developments aided in the growth and that neighborhood developments have increased even more so in 2024. It was brought to the council's notice that Austin approved a modern Unified Development Code and zoning map in late 2024. The mayor also added that the Code Enforcement started operating as a full-time entity since 2023 to better serve the residents of Austin.

Discussing the services provided to residents, the mayor discussed the police department, the fully volunteered fire department which has three stations that cover the city. Mayor Chamberlain also informed the council about the public works department, and the water, sewer, and street departments that fall under it. The mayor also added that all the wastewater is treated internally at the Austin wastewater treatment plant. A \$ 3-million upgrade was completed at the facility. The PWD has also adopted a street conditions map which plans projects for the next several years. The city has one park named the Howard and Edith Martin Memorial Park. A master park plan was completed in 2023 to provide fir future planning of the property. She also discussed with the council that the city selected an engineering firm to work out the plan and applied for a no-match grant for the same. Ms. Rhodes commented and brought to the council's attention, how planning ahead paves the way for major wins after referring to the examples presented by Mayor Chamberlain. Further on, Ms. Chamberlain discussed the businesses that are present in Austin and ended the much praised presentation.

#### 5. Metroplan Update

Ms. Rhodes introduced Ms. Brittany Nichols as the newly added team member of Metroplan. Ms. Nichols will be the new Sustainable Transportation and Energy Ambassador for Metroplan. She added that Ms. Nichols has been working with Metroplan on the CPRG since 2022. Ms. Rhodes quickly mentioned the different CPRG funding opportunities, i.e. Green Networks, and Transportation Efficiency, both of which have a deadline of 21 February, 2025. She also mentioned that Ms. Nichols would be a great contact to reach out for understanding and helping to apply for the grants. Mayor Gastineau asked if Ms. Nichols would be able to aid the small cities with RFP (request for proposal) works and Ms. Rhodes answered that Ms. Nichols would indeed be helpful and the first point of contact for the same.

Regarding the funding opportunities, Mr. Keck asked if anyone has shown interest in the funding for upgrading to LED streetlights, to which Ms. Rhodes and Ms. Nichols gave a positive reply. They informed the council that the City of England, and City of Ward have been looking into it. Mayor Kemp then congratulated Ms. Nichols on helping the City of Shannon Hills with their grants and funding opportunities. Ms. Nichols after thanking Mayor Kemp discussed with the council that the LED streetlights grant opportunity could be used to increase lights on trails, floodlights of parks, or for any bulb that lights up public spaces. It need not be a street light conversion project only.

Mr. Covington then brought to the council's attention that Metroplan has proposed changes to its bylaws, focusing on the election of officers and the frequency of board meetings. Eligible members for officer selection will now include cities, counties, and first-class cities. Proxies will still be allowed, but mayors and judges of CARTS-served cities are encouraged to attend meetings personally. The new executive committee will have one representative from each county which forms the CARTS region. The board members from the Small Cities Council will no longer have a separate seat on the executive committee but they can be voted as representee of their respective counties.

Metroplan sought feedback from the Small Cities Council on the changes. Concerns were raised about the importance of having a small cities representative on the executive committee to ensure smaller cities are informed about decisions. This issue, along with the potential benefits for smaller cities registering as first-class cities, will be discussed in future board meetings. Mr. Covington assured the council that this issue was not to be voted on at this board meeting.

Additionally, Metroplan aims to reintroduce TCC and allow newly absorbed second-class cities to join the Small Cities Council without dues. The council was informed that any bylaw changes require a two-week notice to members, and discussions on these updates will continue in upcoming meetings.

#### 6. Upcoming Grants & Capital Improvement Opportunities:

Ms. Rhodes introduced the council to two new opportunities:

- Coalition for Green Capital
- Local Infrastructure Hub

The Coalition of Green Capital (CGC) uses public and philanthropic funds to mobilize private investments in renewable energy, energy efficiency, and any decarbonization technology installations or research. It will select upto 104 communities 2 in each state and these communities should be serving populations of 10,000 – 750,000 excluding tribes. They should have at least one low-income or disadvantaged census tract to be eligible. The Local Infrastructure Hub is an entity designed for small and mid-sized communities (150,000 or lower). It helps with resources and expertise to access federal infrastructure funding. They also offer technical assistance in grant training that runs for three months. Ms. Curry also seconded the Local Infrastructure Hub's prowess in helping small communities and discussed the upcoming resource programs offered by them. They include training for applying for safe streets for all grant proposals, developing clean energy projects, and many more. Mr. Keck asked the council about their opinion on adding fluoride in the water supply system for cities. Mayor Gastineau replied that there need to add it to the supply and that it is completely optional. He added that fluoride is present in many other substances that we all use in our daily lives so it need not be added to the water.
