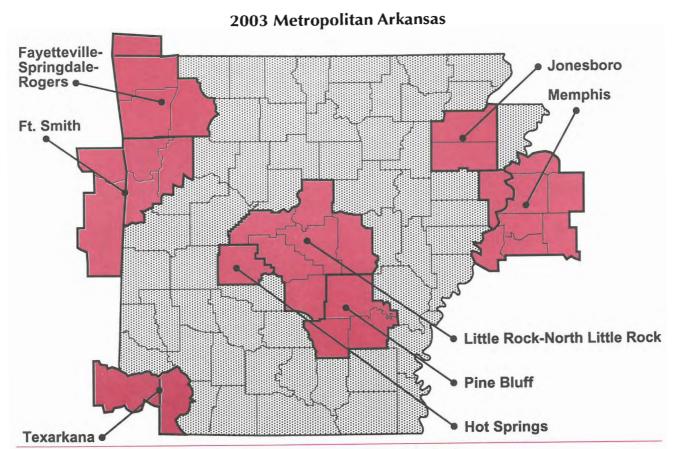
2003 Demographic Review and Outlook

New Metropolitan Geography in Arkansas

On June 6, 2003, the Office of Management and Budget announced the designation of new metropolitan areas under a revised set of standards. The Little Rock-North Little Rock metropolitan region expanded from four counties to six. This action added Grant and Perry Counties to the region, raising its Census 2000 population to 610,518, compared with 583,845 before. The new six-county metropolitan area ranks 77th in size within the U.S.A. Under the old standards, the region had ranked 74th.

There were several other changes to metropolitan areas in Arkansas:

- There is now a Hot Springs Metropolitan Area, consisting of Garland County
- The Fayetteville-Springdale-Rogers MSA expanded to four counties by adding Madison County, Arkansas, and McDonald County, Missouri.
- The Pine Bluff MSA expanded to three counties, adding Cleveland and Lincoln counties, Arkansas.
- The Fort Smith MSA expanded to five counties, adding Franklin County, Arkansas, and LeFlore County, Oklahoma. (See related articles on pages 4 and 5.)
- The Jonesboro MSA expanded to two counties, adding Poinsett County.

Population Estimates for January 1, 2003

The figures at left show Metroplan's latest population estimates. The latest figures include three "firsts." The four-county region passed the 600,000 mark for the first time, while both Faulkner and Saline County both surpassed 90,000. The region continued to grow at an annualized rate of about 1.4 percent. A small population gain in North Little Rock can be attributed to an annexation and the addition of new multifamily housing units.

Next year, in the 2004 issue of the *Demographic Review and Outlook*, Metroplan will publish its first estimates for the new six-county Little Rock-North Little Rock metro area, including Grant and Perry counties.

School Enrollment Demographics in 2003

The figures at right show continuation of school enrollment trends begun during the 1970's, with slight enrollment decline in Pulaski County contrasted with growth in outlying counties. Enrollment growth overall is slowing for demographic reasons. Saline County enrollments have dropped slightly

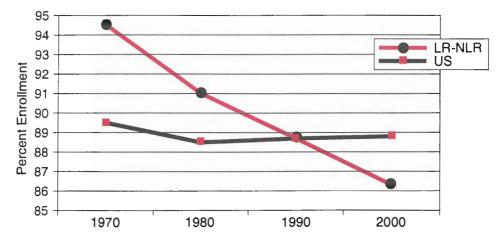
since 2000, probably owing to a comparative lack of children in the youngest age groups. Lonoke County's population structure shows similar characteristics, which might yield enrollment decline in the near future for the same reasons.

The chart below shows public school enrollment as a proportion of total enrollment. As you can see, public school participation ran above the national average during the 1970's and 1980's, but by 2000 had dropped slightly below average. Nonetheless, in 2000 public schools educated 86 percent of the region's young people, or more than four students in five.

The New Little Rock-North Little Rock-Pine Bluff Combined Statistical Area

The new metropolitan standards did more than enlarge several metropolitan areas in Arkansas. They also created a new Combined Statistical Area comprising the Little Rock-North Little Rock and Pine Bluff MSA, along with the new Searcy Micropolitan Area. The three regions were combined based on commuting links. The figures below give further background on this ten-county region.

Housing Permits Hit Record Levels During 2002

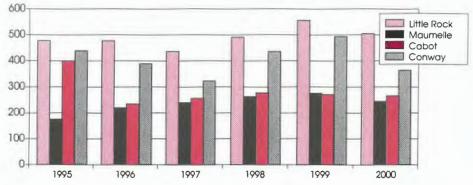
The year 2002 saw the greatest number of new housing units ever permitted during a single year in the history of the four-county Little Rock-North Little Rock MSA. In all, 4,135 new units were permitted during 2002, edging out the old 1983 record of 3,961 units. Single-family housing construction also hit its highest level ever at 2,459, surpassing the 1994 peak of 2,137. While multi-family housing did not quite surpass previous records, the year 2002 nonetheless saw 1,676 new units permitted, the most since 1986.

The leaders in single-family construction were Little Rock and Conway, although neither city quite matched its record high. The cities of Benton and Sherwood hit all-time records, while Maumelle tied its previous record. Cabot and Bryant also had strong performances.

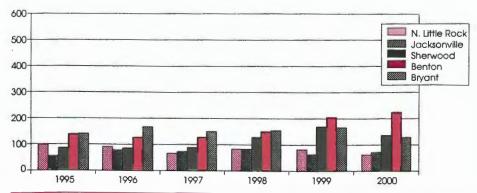
The city of Bryant had the largest number of multi-family housing permits, followed by Conway, Little Rock and Cabot. Benton, Jacksonville and North Little Rock also had significant multi-family construction. Multi-family construction occurred in many different settings, including the near-downtown Argenta Square complex in North Little Rock, the in-fill Parham Pointe project in midtown Little Rock, and a large new suburban complex called The Greens at Hurricane Creek in Bryant. The latter project will have 576 units, and this is just the first phase of a construction process that will eventually yield 1,500 new apartments in Bryant.

The boom in single-family housing during 2002 was driven by the lowest interest rates in a generation. Local multi-family construction appears, meanwhile, to have been driven by the return of local occupancy to the 95 percent range. In response to this solid performance, there has been an in-flow of capital from investors in other regions of the country where apartment market conditions are softer.

Single-Family Housing Unit Permits 1995-2000 Cities Averaging Over 220 Units Annually

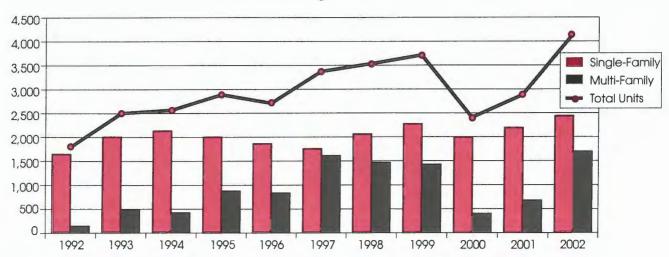


Single-Family Housing Unit Permits 1995-2000 Cities Averaging Under 220 Units Annually

2003 Demographic Outlook

The demographic and economic data suggest that regional population growth continues and may have accelerated since 2000. With unemployment running two full percentage points below the national average and preliminary signs of renewal in local job growth, the regional economy appears sounder than the U.S.

Demographically, the biggest news is that data continue to suggest a turnaround in Pulaski County's twenty-year trend of net out-migration. While the foreign-born population is below the national average, it grew nearly twice as rapidly as foreign-born populations nationwide during the 1990's. International migration, much of it from Latin America, may be the driving force behind renewed population growth in Pulaski County.

The region's outlying communities will continue growing at a more rapid pace. Linear trend analysis suggests that Faulkner County could pass 100,000 population by 2006 and Saline County will reach 100,000 by 2009, if current trends continue.
