I. Approval of minutes of December 17, 2025

A motion to approve the minutes of the December Board meeting was made by Mayor Kemp, seconded by Mayor Chamberlain and passed by the Board.

II. Approval of the Financial Report

Ms. Gillis gave a brief financial report to the Board.

Ms. Gillis noted that included in the Board packet are all of the cash balances at the ending of the year. Staff are starting the prep work for the 2025 audit. All project invoices including CPRG for 2025 have been requested to be received and scheduled to be paid by the end of the year. There will be a review process with Landmark before the start of the audit which will begin in early May and will be conducted by Rasco Winter Thomas.

A motion to approve the November financials was made by Mayor Kemp, seconded by Mayor Gastineau, and approved by the Board.

III. Metroplan Report

Mr. Covington stated to the Board that staff have been working on several projects since the last Board meeting. Metrotrends Economic Review and Outlook was published and mailed out. There was a very interesting article included in this edition on how energy needs are being addressed in the future.

Recently the Faulkner County Transportation Report was completed. Staff will be developing this type of report for each county. Mr. Covington encouraged the Board to stop by and examine the report to get a brief idea of how it will be developed for the remaining counties.

Mr. Covington added that staff are working with the Arkansas APA on a section called “The Passport to Planning”. As part of the program this summer Metroplan will begin its summer internship program and is expected to bring in its first intern. There have been challenges in the state for transportation planning because Arkansas does not have a school. Therefore, this would help in fulfilling the need of bringing in students to the planning profession. The program will be held at UALR and UCA.

Mr. Covington added that there was a congressional direct spending project implemented in North Little Rock. The Main Street Bridge will be turning 100 years old next year and is in desperate need of replacement. The project has been reviewed over the last twenty years. Senator Boozeman included a \$2 million grant towards appropriations for the project to advance.

Mr. Covington further noted that he was in Washington D.C. at the National Association of Regional Councils. The Conway Chamber of Commerce was also having their flyover during this time.

IV. Central Arkansas Regional Planning Needs Assessment

Ms. Palmer provided the Board with a presentation on the consolidation of Metroplan and Central Arkansas Planning and Development District.

Ms. Palmer stated to the Board that a full report of the process was included in the Board packet.

Ms. Palmer began with showing a map that visually highlighted the opportunities of the collaboration of Metroplan and CAPDD. There is a huge overlap of services provided between the two entities.

Ms. Palmer noted that with both organizations there were some similarities in the work as well as each having their own strengths in performance in the region. With

this in mind the deficiency lies in the absence of having a shared long-term regional strategy that integrates planning or cost transportation across economic development. This inadequate cohesion often results in fragmentation of efforts and missed opportunities for reaching resources.

Ms. Palmer stated that there were three collaboration opportunities developed.

1. Institutionalized Collaboration

- Both entities will remain completely independent but formalize a working relationship with one or more MOUs.

2. Co-location

- Both entities will remain independent but share office space.

3. Complete Consolidation

- Both entities combine to become one organization.

Ms. Palmer stated that of the three, Option 3 has the highest level of complexity. At the same time, it is the only option that will allow both entities to achieve the bold change and unified vision that is needed in the region.

Ms. Palmer noted that in the development of the study she spoke with several peer organizations under each option to see how merging together has worked for them.

Ms. Palmer stated that after reviewing these processes it has been decided that Option 3 with a phased approach would work best for the region. She asked that the Board cast a vote to approve Resolution 26-01.

Ms. Palmer also noted that the approval of the resolution would be the first step in a process that could take several years to complete.

Judge Dodson thanked Ms. Palmer for her work in developing a spectrum of possibilities more visible to the Board.

Ms. Palmer added that it was not explicitly stated in the resolution, but she recommended that Mr. Covington be designated as the lead point for organizing the working team. Ms. Palmer suggested that the Board have a discussion prior to voting on the passage of the resolution.

Judge Dodson expressed the need for a second motion on this recommendation. He further indicated that this action taken would have to be duplicated with CAPDD in order to continue the process.

Therefore, Judge Dodson asked that the resolution be approved as drafted and for Metroplan to approve the recommendation as indicated.

A motion was made on Resolution 26-01 by Mayor Kincade, seconded by Mayor Gastineau, and passed by the Board unanimously.

A motion to designate Mr. Covington as the lead point of contact for the reorganization process with CAPDD was made by Mayor Farmer, seconded by Judge Hyde, and passed by the Board.

V. Agency Reports

A. Arkansas Department of Transportation

Mr. Farmahan stated to the Board that the letting for the month of January included:

- Job 0613671 – Hwy. 7 – Hwy 5. interchange
- Job 0619206 - 6.2 miles of Hwy. construction
- District 6 and 8 - Job. 012552 – expected to be finished by June 28th
- Job. C60015 – 0.67 miles in North Little Rock

Mr. Farmahan added that the lettings coming in March will be:

- Overlay job – 15.4 miles of Hwy. 10
- Hwy 9. In Woodson to Hwy. 10

B. Rock Region Metro

There was no one in attendance.

C. Little Rock Port Authority

Ms. Guffey stated to the Board that the Port Authority has an earmark for a workforce training center that will be developed at the Port. The center is part of Pulaski Tech. Ms. Guffey also mentioned that the Rail Crossing Elimination program is moving forward. The technology from the program allows for real-time traffic counts. The traffic sensors have been installed that give real-time data on when the trains are coming through for a more accurate count.

D. Bill and Hilary Clinton Airport

Mr. Shane Carter stated that the curbside canopy on the ticket lobby has been finished, and Southwest Airlines will be launching a non-stop flight to Nashville beginning March 5th. Also, the first phase of a master plan is being developed. Stakeholder engagement opportunities will be held as the plan is developed.

E. FHWA

There was no one in attendance.

F. CAPDD

Judge Dodson noted that Mr. Rodney Larsen and staff were present at the meeting.

Ms. Leigh Ann Pool reported to the Board that the Community Services Department is currently handling 40 different grants that are under construction, 13 projects are waiting for funding, and 19 that are under development.

Ms. Pool stated that for any Board members who submitted for FEMA grants two years ago, funding is starting to be released. She noted if there is anyone with questions she could provide them with a contact source. Ms. Pool further noted that there were several other areas that CAPDD worked with that would be beneficial to this Board. CAPDD would be available to assist with matching contacts for any of the various processes of funding sources needed.

G. Arkansas Municipal League

Mr. Stodola stated to the Board that the League has implemented over the last year a Regional Training Program. A handout was provided that listed some of the services that are offered.

Mr. Stodola mentioned that there will be three Regional Training meetings held and the meeting that would be of interest to this Board is scheduled in Searcy on April 8th.

Mr. Stodola indicated that the one of the handouts discussed Act 398. This act allows first responders to be eligible for 12 counselling sessions by a licensed mental health professional for issues related to their job. This program is funded through the "TAP" (Trauma Assistance Program). Through the program the League assists cities and counties in the area to provide this program to their first responder employees.

H. Congressional Delegates

Mr. Coleman commended Mr. Covington on his participation in the conference in D.C. He stated that he went as part of the City of Conway Chamber of Commerce. He noted that Senator Boozman gave a report on the issues that are being addressed in Conway and suggested that more of the region should participate in the future to make their delegates aware of the things that are in their areas.

Mr. Coleman further stated that appropriations for 2026 have been completed and preparation for the 2027 appropriations process has already begun and

encouraged the Board to keep it in mind for next year.

Mr. Coleman added that the Homeland Security appropriation is set to expire and is funded through February 13th. The Chamber is working on moving forward with the process as quickly as possible.

VI. CPRG

a. Green Networks Call for Projects

Ms. Rhodes reported that the funding opportunity for CPRG Green Networks had been released in January for land restoration, tree planting, and trail construction. The applications for tree planting and land restoration have been evaluated.

Ms. Rhodes indicated that staff worked successfully with the City of Little Rock on transportation efficiency to identify vehicles to replace with EVs. The Central Arkansas Library System has sought EV charging at nine of their locations. Ms. Nichols provided Quality Assurance Training for the efficiency program. Streetlight replacement has begun in the City of Alexander and the City of Sheridan.

b. Central Arkansas PACE

Ms. Rhodes further noted that at the Airport 152 of the 710 Geothermal wells have been installed. The project is expected to be completed by May. Last month the Board approved funding for the City of Ward's building efficiency project. The contract for the project is currently under review and close to execution.

Ms. Rhodes stated that land restoration and tree planting applications have been received and are currently under review. Recommendations are expected to be completed and presented at the March Board meeting. There are six projects under consideration for approval at the meeting today. The projects will overall restore about 10,000 acres of land with 166,000 trees. Combined with the projects that were approved in Round 1, staff will have exceeded all of the goals for land restoration and preservation.

Ms. Rhodes commended the efforts of Ms. Nichols, the Sustainable Transportation and Energy Ambassador for the region through the CPRG grant for all of her hard work in making this program a success.

A motion to approve Resolution 26-02 was made by Mayor Farmer, seconded by Mayor Gastineau, and passed by the Board.

VII. SMART Streets Plan

Mr. Holland stated to the Board that a Vision team meeting has been rescheduled for Wednesday, February 18th. The meeting will be primarily technical staff and invitations to several mayors were sent out optionally.

Mr. Holland asked if anyone is interested in attending the meeting please notify him because space is limited. The meeting will be held at ARDOT.

VIII. Call for Projects

a. 2026 STBG and 2026 TAP

Mr. Holland noted that there are two supplemental funding call for projects that were issued in January. There were 15 applications received with 7 of them listed as priority 1 and 2, which were fully funded requests. The other 8 projects were given under contingency awards. Once the final bid and funding is determined, the bid on the projects will be adjusted. Staff will re-evaluate in July to make sure that they are ready to go to bid by the end of the year.

A motion to approve Resolution 26-03 was made by Mayor Gastineau, seconded by Mayor Chamberlain, and passed by the Board.

b. 2027 TAP Funding

Mr. Holland stated that there are a total of 8 applications for projects for the Transportation Alternatives 2027 Program funds. These projects are a mixture of new design, construction funding, and right of way. There was an evaluation by a team of 5 scorers. Six projects were recommended for awards. The information for each specific award was included in the Board packet.

ARDOT has just released its call for TAP projects. Staff is available to assist members with applications.

A motion for Resolution 26-04 for final approval of the awarding of the projects was made by Mayor Brumley, seconded by Mayor Farmer, and passed by the Board.

IX. FFY 2026 Obligations

Mr. Holland stated to the Board that for information only in the next couple of weeks staff would be meeting with ARDOT to determine what projects should be obligated in the upcoming year.

Mr. Holland noted that projects that were obligated last year and expected to be obligated in 2026

will be on the initial plan. A couple of projects that were held up in 2025 and just missed obligation for various reasons are expected to be included. Also, the projects from priority list 1 and 2 along with contingent projects will be on the list as priorities 3 and 4.

Ms. Rhodes introduced Mr. Jonathan Rasbury with the Arkansas Advanced Energy Foundation to bring a presentation to the Board.

Mr. Rasbury stated to the Board that he is the C-PACE Administrator with Arkansas Energy Foundation, which is part of the CPRG program. Over the last year staff have taken the C-PACE program, which was an existing program in the state that went defunct and is now being revamped. The program is a low-interest long-term loan program for efficiency projects for retro fits, new construction and revamps to efficiency in the form of a property tax assessment as opposed to a loan. In Arkansas the program is commercial only. Any commercial building, agriculture, or non-profits are eligible to apply.

Mr. Rasbury noted that the next step in the process is now to get counties to participate. To get a county to join there is a draft ordinance that will come before the quorum court, as well as a participation agreement that outlines the responsibilities for the county which requires a county member to sit on the PACE Board. There is no financial obligation needed by the entity. Once they have joined and signed the participation agreement with Pulaski County, businesses in the county can take advantage of the program.

Mr. Rasbury stated that any further questions could be directed to him and through the website.

With no further business, the meeting was adjourned.

ITEM 2. FINANCIAL REPORT

The preliminary Metroplan 2025 Operations Budget to actual expenditures is included in the packet. Metroplan continues to review preliminary numbers in preparation for the Metroplan audit scheduled for June.

A cash summary is also provided for March 1st.

SUMMARY

On February 26, the Central Arkansas Planning and Development District Board of Directors approved moving forward with investigating a merger of the two organizations.

Green Networks Trail Construction Funding Recommendation

On November 19th, Metroplan issued calls for projects for three Green Networks measures: multi-use trails, land restoration, and tree planting. Applications were due January 9th. Land restoration and tree planting funding was awarded at February's board meeting.

Metroplan received 6 trail construction applications for a total of \$4,935,285.52. The remaining balance in the trail construction budget is \$2,318,400.00.

The table below summarizes the funding proposals and the projects' cost-efficiency, i.e. \$ cost per metric ton of CO2 reduced by the trail, which is based on a calculation of vehicle miles offset by the trail from an adjacent roadway. The right-most column, \$/MT by % attributable, is the cost-efficiency indicator based on the percentage of the project being paid for by CPRG.

ITEM 7. 2027 Unified Planning Work Program

SUMMARY

The Unified Planning Work Program (UPWP) includes all transportation planning activities conducted within the Metroplan study area. In May 2025, Metroplan adopted a two-year UPWP covering the period from July 1, 2025, to June 30, 2027.

For a two-year UPWP, the second year is reviewed and may be revised fort. Metroplan staff expects to complete all tasks/deliverables within the two-year period. No adjustment to work tasks are proposed.

Metroplan budget adjustments are proposed for the following.

1. Consultant cost for the CARTS Travel Demand Model Upgrade (include in Metroplan's 2026 budget)
2. Safe Streets and Roads for All Demonstration Grant (Updated)

SUMMARY

A. 2027 Surface Transportation Block Grant Funding

The annual 2027 STBG call for projects will be released in April and projects will be awarded during the June Board meeting. Please submit a letter of intent to apply by April 15th. The letter of intent must include a description of the project that details the name of the facility and the expected improvements to be made.

The call for projects will use the same application and scoring system as prior applications. A clarification will be provided for project scoring that benefits a parallel route.

ITEM 9. 2026 PROJECT OBLIGATIONS

SUMMARY

Metroplan must obligate \$21.65 million of funding for FFY 2026. This amount included new funding for FFY 2026 as well as carryover funding from 2025. The project list includes projects previously awarded funding in prior calls for projects and supplemental funding awarded in February. Staff continue working to identify the projects that will be ready to move forward and will work with sponsors to ensure obligation.

JP Wright Loop Railgrade Separation is ready for closeout and requires an additional \$117,951 based on final charges. Resolution 25-06 awards this funding from the supplemental funding call for projects for 2026. The final amounts for other projects will be confirmed in June/July as projects are confirmed for bids.
